Niagara Mohawk Power Corporation, The Brooklyn Union Gas Company, and KeySpan Gas East Corporation (together “National Grid” or “the Companies”) submit this Notice of Stakeholder Informational Session pursuant to the *Order Adopting Gas System Planning Process* issued by the Public Service Commission (“Commission”) on May 12, 2022 (“Order”). The Order requires, among other things, that each local distribution company (“LDC”) hold an informational session prior to the date the LDC will file its initial long-term plan. The Companies’ initial long-term plan will be filed on or before May 31, 2024.
